Each student received a \$500 scholarship from the Chamber to attend BBTC.

are funded by financial support received from Mike Hunter and E-Transport.

BBTC announces summer programs

While the enrollment period for the summer welding program was closed, it is not too late to sign up for summer GED classes at Big Bend Technical College (BBTC). Summer tuition for the GED program costs \$30, plus a \$15 application fee. "Students can attend morning, afternoon, or both sessions with a \$30 tuition," BBTC Director Jodi Tillman said. BBTC's summer schedule is as follows:

Student Services office: open 8 a.m. - 4 p.m., Monday through Thursday.
 GED classes: 8 a.m. - 12 p.m. and 1-5 p.m., Monday through Tuesday; 8 a.m. - 12 p.m. on Wednesdays.
 Day welding classes: 8 a.m. - 3 p.m., Monday through Thursday.
 Night welding classes: 6-9:15 p.m., Monday through Thursday.
 Two summer program times are available: June 10-27 and July 8-25.
