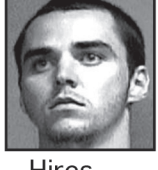

The Big Bend Water Authority ("Authority") will hold a public hearing on **Thursday, July 25, 2019, at 4:45 p.m. at 1313 1st Avenue SE, Steinhatchee, Florida.** The purpose of the public hearing is to receive public comment and consider the tentative budget for Fiscal Year 2019-2020. The public is also free to state any objections to or support of the budget and rates.
