The last memory Will Smith has of his son will be a glimpse in his rearview mirror of Bruce walking into a convenience store.

Bruce Smith was last seen on Sept. 8, when he met with his father at a convenience store in Ocala, one hour north of where they lived in Tavares, Fla.

"I filled his tank and gave him \$10 for food. When I was pulling out, he was going back into the store to get something to eat. When I realized he was not coming home..." a tearyeyed Will Smith paused to catch his breath.

"If I had driven him home...maybe...just maybe, he would not have died on me," the grief-stricken father continued.

The past two weeks have been a nightmare for Bruce Smith's family, as they have traveled to Perry four times to search, while his mother, Donna Smith, stayed in Tavares awaiting her son's

"She cleaned the car, cleaned his room. She even washed his laundry," Bruce Smith's sister, Tara Erkert,

"She wanted it to be nice for him," stepmother Belinda Smith added.

According to family members, Bruce suffered schizophrenia, bipolar disorder and manic

depression for more than 23 years and had been self-medicating with street

"I feel like he was crying for help for so long. We tried, but we should have been more vigilant. It is hard to make an addict dry up until they are willing to do it," Erkert said with a grimace. "Bruce is finally at peace from his demons and in the hands of his savior."

His family remembers him for the "fun, carefree spirit" he was.

"When we named Bruce, we were trying to think of a middle name. We kept going back and forth, back and forth. We thought wait a second, 'Wayne.' We did not think about it after that, but his grandma started calling him 'Batman'," Will

Smith laughed. "His mom

"It ended up being his nickname, though," Erkert

Bruce Smith was known for his generosity, strong work ethic, cooking skills and love for his family.

"He was too giving. He would go over and beyond. I can't tell you how many times he would give me a gift card for groceries just for the heck of it," Erkert

"He knew you needed it, though," Will Smith interrupted.

"Yeah, I was a single mom of two kids for 12 years. He was looking out for me," Erkert added.

In the wake of the tragedy, Bruce's family is clinging to their fond memories of him, and his once estranged family members are grieving their loss as a united family.

"This was a family divided before all of this happened. There was a lot of butting of heads. I told Belinda three or four days ago that something positive had to come out of all this chaos. Bruce created a miracle by bringing us all together," Erkert said.

Bruce Smith is survived by his mother, Donna Smith, his father and stepmother Will and Belinda Smith, siblings Tara (John) Erkert, Sara (Brian) Erkert, aunts Tracy Harper, and Terry Selg, an uncle Corey McLaughlin, five nephews, Zachary, Nicholas, Justin. Samuel and Seth, and a niece, Naomi.

On 3rd down, Thomas threw an incomplete pass just outside of the red zone before Azerte split the uprights with a 35-yard field goal attempt with 28 seconds remaining in the second quarter.

Gates will be locked on this date (Sept. 27) and will be routinely monitored by Four Rivers' staff, as well as law enforcement officials.


