installer and mechanic), Practical Care Technician, Practical Nursing, Welding Technology and Advanced Welding Technology.

Tillman stated that new program possibilities at BBTC include: Electronic Technology 2, HVAC Technician and/or Paramedic.

Tillman presented а BBTC's slide showing enrollment numbers from 2012-13 through the current school year (2019-20), showing the technical college has recorded its highest enrollment numbers in each of the two most recent years, including 355 last year (2018-19) and 360 two years ago (2017-18).

BBTC enrollment has students averaged 270

over the past eight years, and the school already has 251 students enrolled in the current year - which includes only fall classes.

"Once, spring enrollment is added in, we project to be at or slightly above last year's total enrollment numbers," Tillman said this week.

In addition to offering CTE industry certifications, BBTC also provides a GED Preparation Program, ABE (Adult Basic Education) classes and Applied Academics for Adult Education (AAAE).

BBTC had 31 GED diplomas reported in 201819, and the Perry Elks Lodge donated \$1,000 in adult education scholarships.

Tillman presented school board members with a graph highlighting BBTC's the overall graduation rate (88%), completion rate (90%) and placement rate (96%) for all programs.

According to the data presented by Tillman, BBTC's Patient Care Technician (100%) and Practical Nursing students (85%) have a combined 92.5% licensure rate.

BBTC students earned a total of 124 industry certifications during the 2018-19 school vear including: • Diesel Engines (1),

- Diesel Brakes (2),
- National Licensed

Practical Nurse (NCLEX-PN) (13),

• American Welding Society (40),

• Massage Therapy (4),
