In conjunction with Volunteer Florida, Taylor County Emergency Management will host a public informational meeting on March 12 to launch a "long term recovery group" (LTRG).

The meeting will begin at 2 p.m. at the Emergency Operations Center located at 591 East US 27. The community is invited to attend, but it is requested that those who plan to attend RSVP by calling the Taylor County Sheriff's Office Division of Emergency Management Office at (850) 838-3575.

A LTRG is a cooperative body that is made up of representatives from faith-based, non-profit, government, business and other organizations working within a community to assist individuals and families as they recover from disaster.

The decision to begin a local LTRG comes after several counties that were impacted by Hurricane Michael have demonstrated much success working through their county LTRGs.

According to Division of Emergency Management Director Kristy Anderson, recovery following each disaster is unique and may last weeks or years.

Community-driven LTRGs provide opportunities for the community to take control of its future, facilitate recovery and to bring in participants and leaders from non-traditional sectors within the community.

"Taylor County is blessed to have caring helpful citizens that join together in time of disaster or need," Anderson said in a release.
