

# Rotary offers scholarship to high school seniors

The Perry Rotary Club is accepting applications from high school seniors for the Grady C. Moore Memorial Scholarship, which will \$2,000 to a Taylor County student.

The scholarship is open to all Taylor County graduates in the Class of 2020 who plan on attending college this fall, including current seniors at Taylor County High School, Point of Grace, Aucilla Christian Academy and those who are homeschooled.

Those wishing to apply are asked complete the scholarship application and write as essay (two-page maximum) about what the Rotary axiom "Service Above Self" means to them. For the full rules and the application, e-mail marlex7@gmail.com.

The application deadline is Friday, May 29.

The \$2,000 scholarship will be paid \$1,000 per semester for two semesters.

The scholarship

recipient must enroll in college in the fall semester following graduation and provide the Perry Rotary Club documentation of enrollment prior to the start of the semester.

Payment will be sent directly to the college or university each semester after receiving proof of enrollment for that semester.

A committee of Rotarians will make their selection based on the applications presented to the club.

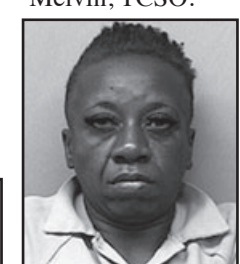

**AN ORDINANCE OF THE BOARD OF COUNTY COMMISSIONERS OF TAYLOR COUNTY, FLORIDA, PROHIBITING BUSINESSES WHICH DERIVE ANY FUNDS, REMUNERATION OR BENEFIT OF ANY KIND FROM ANY SIMULATED GAMBLING DEVICE INCLUDING SLOT MACHINE-LIKE SPINNING REELS, VIDEO DISPLAYS OR OTHER SIMILAR TECHNOLOGY TO DISPLAY THE RESULTS OF A RAFFLE, SWEEPSTAKES, CONTEST OR OTHER PROMOTIONS; PROHIBITING THE USE OF ANY SIMULATED GAMBLING DEVICE INCLUDING SLOT MACHINE-LIKE SPINNING REELS, VIDEO DISPLAYS OR OTHER SIMILAR TECHNOLOGY TO DISPLAY THE RESULTS OF A RAFFLE, SWEEPSTAKES, CONTEST OR OTHER PROMOTIONS; MAKING FINDINGS; PROVIDING FOR ENFORCEMENT; ESTABLISHING EXEMPTIONS; PROVIDING OF REPEAL OF CONFLICTING ORDINANCES; PROVIDING FOR SEVERABILITY; PROVIDING AN EFFECTIVE DATE.**
