



### TCHS hosts ceremony for COVID family

Taylor County High School (TCHS) hosted a private graduation ceremony on Thursday, June 18 for Naomi Stading after she was forced to miss the high school's traditional ceremony due to the coronavirus. Stading's father, Jeff Stading, was hospitalized after he tested positive for COVID-19 on May 27, just two days before Stading was set to walk the stage. Stading, her mother and her six-year-old sister tested positive shortly after her father. "We decided to give Naomi a small, private ceremony because she was unable to attend her own graduation due to her family's exposure to COVID. Naomi has been an involved student throughout her years at TCHS -- including band and JROTC -- and we all wanted to give her the recognition that she deserved for her accomplishments," TCHS Principal Heather McCoy said.

# New rule begins Monday

players moving down, raising some concerns about gamesmanship — but overall felt there were many benefits under the new rule.

As for now, per the FHSAA's guidance, the clock for a week under the new six-quarter rule would start on a Monday and end on a Saturday.

Hamilton County Head Coach Kirkland Mitchell said the rule change will be a great asset as he attempts to rebuild the school's football program.

Mitchell told the Suwannee Democrat that the rule change is "awesome."

"You've got the little

tweeners that aren't ready for varsity. You've got these ninth and tenth graders that aren't ready for varsity, but they're stuck on varsity and they're not getting better because they're not playing," Mitchell said.

"Now, you move those guys down and let those guys get reps, and then they can get out on varsity... You've got to have that feeder system," Mitchell said.

According to the Suwannee Democrat, Suwannee County Head Coach Kyler Hall said even though his Bulldogs are a Class 5A program, they could benefit from the rule change, as well, with some players that could help out on Friday nights while also

developing in junior varsity games.

"I think if you do it correctly and have a plan with it, it could benefit anybody. Take the sophomore class for instance. That's still a developmental year for a lot of kids, so they may not be ready to fully go up to varsity. You can still get them reps down on JV, instead of just sitting on the sideline on Friday nights. Then you still have that option to bring them up and if you can get them some reps on Friday night, then great. But at least they're still playing and you get to see them develop," Hall told the Suwannee Democrat when asked about the newly-approved FHSAA rule.
