

Glover talks COVID, safety with Corcoran

Taylor County Superintendent of Schools Dr. Danny Glover Jr. was one of 12 district school superintendents who met with Florida Education Commissioner Richard Corcoran on June 1 to discuss budget needs and how to best bring students back to school in a safe and secure manner.

Glover joined fellow superintendents Jeff Edison (Levy County), Ted Roush (Suwannee County), Robbie Edwards (Lafayette County), Rex Mitchell (Hamilton County), Sherrie Raulerson (Baker County), Dr. Kathy Burns (Nassau County), Rob Rankin (Gilchrist County), Dr. Rick Surrency (Putnam County), Stacey Creighton (Bradford

County) and Carlton Faulk (Union County) at the home of Dixie County School Superintendent Mike Thomas, who hosted the event.

Topics of discussion included the impact of COVID-19 on school budgets, the health of students and the best way to re-open schools.

Commissioner Corcoran explained the effects of the COVID-19 shutdown on the state budget and how this might affect local school budgets.

Superintendents in attendance expressed their sincere appreciation for Corcoran taking time to meet with them and expressed how small districts in rural areas face

much different challenges than large, urban districts.

One main topic that continued to arise was the desperate need for additional broadband internet access in rural communities.

Superintendents told Corcoran they look forward to working with the state to provide a safe re-opening of schools for students and staff in August.

“We appreciate the commissioner’s dedication to the public education system and his willingness to listen to the superintendents from small and rural districts. We hope that this collaboration and partnership continues to grow,” Glover said.

DOH on mosquito and tick bite prevention

The Florida Department of Health in Taylor County (DOH-Taylor) is urging residents, especially those who are spending time outdoors, to protect themselves from mosquito and tick bites this summer season.

“While most tick and mosquito bites are only an annoyance, sometimes these bites can be dangerous. Preventing bites reduces the risk of a person getting infected with a mosquito- or tick-borne disease,” Bill Gibson of DOH-Taylor said in a press release.

Using the right insect repellent and other

preventive actions can discourage mosquitoes from landing on you, Gibson said.

Follow these “drain and cover” tips to help prevent mosquito bites:

- Drain water from outside areas to reduce the number of places mosquitoes can lay their eggs and breed. These outside areas may include: garbage cans, house gutters, buckets, pool covers, coolers, toys, flowerpots or any other containers where sprinkler or rainwater has collected.

- Discard old tires, bottles, pots, broken appliances and other items

not being used.

- Empty and clean birdbaths and pets’ water bowls at least twice a week.

- Protect boats and vehicles from rain with tarps that do not accumulate water.

To protect yourself, wear protective clothing while outdoors and keep doors and windows closed to prevent mosquitoes from going indoors.

Protective clothing can include: shoes, socks, long pants and long sleeves

You should also use insect repellent that contains DEET (10-30%), picaridin, oil of lemon eucalyptus, para-menthane-

diol, 2-undecanone or IR3535.

Additionally, clothing and gear can be treated with products containing 0.5%. Do not apply permethrin directly to skin. Some sports clothing and gear come pretreated with permethrin.

Additionally, you can:

- Use mosquito netting to protect children younger than 2 months old.

- Check and repair screens on doors and windows. Keep them closed and use air conditioning when possible.

Ticks are commonly found on the tips of grasses

and shrubs and climb aboard humans as they walk by.

Follow these steps to help prevent tick bites:

- Wear long-sleeved shirts, pants, boots or sturdy shoes, and a head covering. Ticks will be more visible if clothing is light-colored.

- Apply insect repellent that contains DEET (10-30%), picaridin, oil of lemon eucalyptus, para-menthane-diol, 2-undecanone or IR3535.

- Treat clothing and gear with products containing 0.5% permethrin. Do not apply permethrin directly to skin. Some sports clothing and

gear come pretreated with permethrin.

- Check for and remove ticks from your clothing, body, hair, and pets when you have been outside.

- Washing clothing in hot water or tumbling dry clothing in the dryer for at least 10 minutes set at high heat will kill ticks.

- Shower soon after being in tick habitat.

If a tick is found on the skin it is important to safely remove the tick as soon as possible.
