- member Require schools to monitor heat stress and modify athletic activities based on heat stress guidelines, including making cooling zones available;
- Establish hydration guidelines, including appropriate introduction of electrolytes; and
- Require each school's action plan emergency to include a procedure for onsite cooling using cold-water immersion or equivalent means before transporting a student for exertional heat stroke.

The bill requires students participating in conditioning and activities that occur outside of the school year to pass a medical evaluation prior to participation in such activities each year.

The bill passed unanimously in both the House and the Senate.

### CS/CS/SB 404 -Abortion

The bill amends the "Parental Notice Abortion Act" to add consent requirements and renaming the act as the "Parental Notice of and Consent for Abortion Act."

The bill prohibits a

physician from performing an abortion on a minor unless the physician has received a notarized, written consent statement with specified language signed by the minor's mother, father or legal guardian. The bill includes several exceptions to the consent requirement, including medical emergency and if the minor petitions the circuit court and receives a judicial waiver.

The bill passed the Senate 23-17 and the House 75-43. Montford voted "no" and Shoaf voted "yes."

### CS/CS/HB 971 Electric

The bill addresses the definition and operation of electric bicycles (e-bikes) within a three-tiered classification system. The bill creates regulations governing the operation of e-bikes, affording an e-bike or e-bike operator with all of the rights and privileges, and subjecting them to all of the duties, of a bicycle or bicycle operator.

E-bikes are authorized to operate where bicycles are allowed, including, but not limited to, streets, highways, roadways, shoulders, bicycle lanes and bicycle or multi-use paths. However, the bill provides that the new e-bike regulations do not prevent a local government from regulating the operation of e-bikes on streets, highways, sidewalks and sidewalk areas under the local government's jurisdiction; or to prevent a municipality, county, or agency of the state having jurisdiction over a bicycle path, multi-use path or trail network from restricting or prohibiting the operation of an e-bike on such paths or trail networks.

The bill unanimously in both the House and the Senate.

### CS/CS/HB 1259 – **Incarcerated Pregnant** Women

The bill amends 944.241, F.S., renaming it the "Tammy Jackson Healthy Pregnancies for Incarcerated Women Act." The bill prescribes procedures for when a pregnant prisoner is placed in restrictive housing and requires detention facilities to adopt written policies about using restraints and body cavity searches on pregnant prisoners.

The passed unanimously in both the House and the Senate.

and during their inevitable arguments.

Outside of those two, the biggest standout is Stevens, who just chews up the scenery whenever he is on the screen. In most films, he would be the primary villain, and although he does provide many of the stumbling blocks Lars and Sigrit face along the way, there's a lot more to his character than I was expecting.

There is a villain of sorts, and it's obvious he's there so the story can claim the semblance of a plausible reason for some of the major plot developments in the first act, namely why a band so obscure and moderately talented would end up at the Eurovision Song Contest. It's a plot thread that is given the minimum amount of development and is eventually tossed aside when it's no longer needed (although it does lead to a funny gag near the end).

My biggest issue with the movie is just how long it is. At two hours, it feels like a good 15-20 minutes could have been trimmed to help pick up the pace and streamline the script. Overall, the story feels scattered most of the time, and although that works to Ferrell's strengths,
