Suspended license? New rule in effect

Those who want to get back behind the wheel of a vehicle after a one-year suspension or expiration period will now be required to take and pass the written portion of the exam before being issued a Class E driver's license.

Previously, those wanting to have their licenses reinstated simply paid a fee and did not have to complete the written

However, beginning Feb. 15, according to a Florida Highway Safety and Motor (FLHSMV) Vehicles technical advisory bulletin, drivers who have allowed

their license to expire or who have not operated a vehicle for a year or more due to a license sanction will be required to pass the written "knowledge" examination.

"Basically, as of Feb. 15, 2021, this technical advisory bulletin will affect those with driver's licenses that have been expired for a year or more," Taylor County Tax Collector Mark Wiggins explained.

"It will also affect those who downgraded from a driver's license to an ID card and have not changed back within a year," Wiggins added.

"The state of Florida now requires you to re-take the knowledge/written portion of the driving test. If you recently lost your license, I would suggest that you do all that you can to get your driver's license re-issued as quickly as possible so that you do not have to take the written portion again. This new requirement is a state mandate and not a local tax collector's office decision," Wiggins said.

The Feb. 8 FLHSMV bulletin states that it is the intent of the Florida Legislature that every applicant for an original driver license in the state

be required to pass an examination.

"In order to ensure Class E driver license customers who have not operated a vehicle for one year or more remain knowledgeable of vehicle driving laws, effective February 15, 2021, these customers will be required to complete and pass the Class E knowledge exam to obtain a Class E driver license," the advisory states.

"Customers who have allowed their Class E driver license to expire for one year or more, whether due to a license sanction or downgrading to an

identification card, will be required to complete the Class E knowledge exam and vision exam prior to obtaining an original Class E driver license," the bulletin states.

Even those customers who have completed the Class E knowledge exam, but have not applied to have a license issued within one year of the exam date, will be required to be

re-tested.

Other examples of when a customer will be required to re-test for their original Class E driver license include:

• Customer downgraded

from a Class E to an ID card due to a license sanction and the driver license on record has been expired for one year or more.

· Customer's Florida Class E expired, and the customer did not apply to renew the Florida driver license within the one-year delinquent renewal period.

· Customer is applying for an original Florida Class E license and their out-of-state driver license has been expired for one year or more.

"As always, we are here to help you with any questions you may have," Wiggins added.

TICO Through the program, Demps encouraged children to participate in the Bible Bowl, a national competition that quizzed 3rd to 12th-graders on

In 2006, Demps launched the Arms of Bethel Community Development Center in Mayo, which was dedicated to facilitating an award-winning statewide abstinence program.

While the 75-year-old Demps is less involved with the youth these days, her community center continues to impact young people, as it transitioned into a Boys and Girls Club

Between teaching, mentoring and pastoring, Demps somehow found time to earn a master's degree from FAMU, serve as president of the Taylor Education Association (TEA) from 1982-83, cofound a singing group of educators aptly named "Daughters of Harmony," serve as co-pastor of Christian Tabernacle for 33 years and raise two children with "God-fearing, Godly values."

Reflecting on her life, Demps laughed, saying, "Lord have mercy, I did a lot. I did not even realize I did so much....But it makes me feel good."

Demps retired from teaching in 2000 after a 30year career as an educator.

During her undergraduate studies, Demps went through a time where she struggled to maintain her grades and considered quitting school - a decision that would have changed the course of her

"It was all that hanging out in the student union, watching soap operas," Demps laughed. "But I turned it around with God's

"I just finally gave up and said it is ridiculous that I am wasting my momma's money and my time. When I looked back, I saw that I had wasted so much of my time and energy," Demps said, continuing, "I said, 'I can do better than this.' And I did.'
