May 12:
It's shaping up to be a pretty nice spring in the old county here. I noticed the pines are putting on some nice growth. A lot of folks are counting on those trees all over, with our need to make lumber and paper. Heck, I even have a few.

My garden is keeping me hopping and hose dragging, but yesterday we got our first measurable rain in May.

It's also a good time to move plants with a pair of post hole diggers. I have some skips in my okra I will fill in.

I delivered Lilith to Johnny and Gay. She is only a few miles away on Golf Course Road.

John insisted on paying me for her, so I threw the suck bucket in too.

Right after I left with the trailer, Gay had him running to

the store for powdered milk. Poor Johnny.

With the heifers gone, all that is left is the barnyard stock, and it just seems a little lonely, which I suppose you're not suppose to admit to.

I need to clean out the freezer for the summer refill and move those okras.

May 18:
The old homestead is still standing, even if it is slowly going to heck, I reckon.

You don't have to look hard to find something to do.

I've got to get the mower on the green tractor and start that work. You can make good progress or work using a mower

I've been killing popcorn trees, but they're still all over and probably will be in spite of all I do.

I'm going to call Mr. Ed Straka and see if he wants to work on my old tractor. The rear lift has been out for years -- maybe he can fix it.

I've been keeping them under a shelter the last couple of years, but I fear the old Ford may be water damaged.

I need to call Johnny and see what he's doing -- probably very little. He needs to be watering that garden and quit fooling around!

I gotta go water that garden and crop some collards. I got my first-ever bush cucumber yesterday.

The cutworms are helping me with the thinning in the okra and peas. They are just taking forever to grow past that tender stage.

May 23:
It's "the dry month of May" as

Pap always said, and you better leave the fertilizer in the bag.

I've broken loose with the bushhog on the back 60 and mowed a little of the worst in the last few days.

I'm mowing around Mona's old pine grove. It is a jungle out there, with a lot of logs on the ground and vines going up the trees.

These are the last of the trees Aunt Elizabeth helped Grandpa plant some 70 years ago. There are maybe 40 or so left.

I also found a group of stove wood that I will use this winter. Old lighters is getting scarce.

We're still hoping to haul calves Tuesday, but only a few -- prices are poor I hear. Remember, eat beef!

May 25:
I just want everybody to know I'm home after a tedious trip to the market.

The floorboards on my trailer shifted, creating gaps that a cow's feet could go through. I threw in a piece of plywood that covered them and went on, but it was still scary.

Johnny and I took the back roads and made it there and back safely. I was tired, but thankful -- mostly for Johnny, Mike, Mark and Tippy, who had the cows in the pen in record time.

Cowboy up folks!

June 4:
I gathered up a tub of cow manure to go around my tomato and pepper plants. It's been dry, but pretty weather -- not too terribly hot or bad humid yet.

With just a few biting bugs, we have been enjoying the afternoon

dips in Rocky Creek.

I've been doing underwater raking to clean up the bottom, and then I plop into an inner tube and just stare up at the power lines. Hillbilly heaven!

I finished the stock trailer and put it away.

I'm going over to the grove in the morning to help Andy take out a few dead orange trees.

I am going to take him a nice grocery bag of orange-fed beef to enjoy.

June 7:
I had a great weekend, starting Saturday morning helping Andy take out three or four orange trees. He worked me like a rented mule until I balked on him and started griping about a dull blade (I found some wire).

I mostly cooked and cleaned yesterday, and we got a little rain, which was so wonderful and cool.

Johnny and Gay came over with a pie. The roast was tender,

but dry, which made the ice tea go over real good.

My biscuits were a flop, so we ate light bread. I made squash, carrots and baked potatoes. We ate half the pie.

I need to run. I have to pick over the garden and sharpen the saw blade.

I will be heading back over to Andy's to finish those dern orange trees -- the old boy had some bad freeze damage.

Then, I need to sharpen my mower blades and tackle the yard.

At least I have plenty of leftovers cooked.

I have also got a Suwannee trip planned for Thursday.

Y'all try to find something to do!
