Around 5 p.m. on Feb. 20, Rack Up Thrift Store manager Doris Holton was closing up for the day when she smelled smoke.

Thinking that the property owner might be working in her craft room on the side of the building, Holton opened the door and called out, but the property owner was not there

Looking around, Holton noticed smoke coming from a corner of the room and then saw flames shooting out of the electrical panel.

Grabbing her purse and the store's iPad, Holton escaped outside and called 911.

Intense fire and thick smoke quickly engulfed the entire building, despite Taylor County Fire-Rescue crews working tirelessly to put out the fire and prevent the flames from spreading to surrounding properties.

By the next morning, with one fire truck still on scene, all that remained of the Rack Up Thrift Store in Steinhatchee was a pile of charred debris.
