Two drivers cited following collision

Two drivers walked away soggy — but otherwise uninjured -- from a two-vehicle crash that occurred during a driving rainstorm on Old Dixie Highway on Tuesday, July 19.

A 1995 F-150 traveling southbound on Old Dixie Highway was struck from

behind as the driver slowed to make a left turn onto Poppell Drive.

The driver of a 2008 Ford Focus was cited for following too closely, after it failed to stop, resulting in the Focus rear-ending the F-150.

According to Perry Police Department Capt. Gene

Franklin, the driver of the F-150 was cited for a non-moving violation for not immediately reporting the crash to law enforcement, but instead continued home despite the collision, and drove back to the scene of the crash several minutes later.

"[The driver of the F-150]

advised she was scared and shaken up, so she just continued home following the crash," Franklin said.

No one was injured in the crash, but the Ford Focus sustained "disabling damage" and had to be towed from the scene.
