By that time, I had only about 10 days until I was scheduled to leave Vietnam for good to head back home.

I talked to Sgt. Richardson about when my last day would be with the PBR Unit, and we decided that because I had to return to my original unit (A Company, 1st of the 8th Cavalry) to officially clear out before heading home, I could leave the unit on February 25, 1969

I said my goodbyes to Sgt. Richardson and the rest of the guys in Quin Nhon on the mornina of Feb. 26, 1969, telling Kenneth Swanson that I would write to his father and let him know when I was coming to pick up the pieces of the PA-20.

He asked me to hold off, if I could, until he was home so I would have help. He only had about six months left in-country at that time.

I was able to catch a ride with a convoy of trucks headed to Pleiku. From there, I caught a Chinook to An Khe, where the 1st Cavalry Division was based. From the heliport I was able to find the 1st of the 8th's rear area and got a cot for the night in their transient barracks.

Travel to this point had taken

up most of the day, and I did not start clearing my paperwork and gathering up my war souvenirs until the following morning -- Feb. 27, 1969.

Before going to bed that night, one of the orderlies showed me where the closest bunker to my barracks was located.

He told me that while Charlie had left them alone lately, they were due for a good rocket or mortar attack.

His words would prove prophetic. At about 3 a.m., I was awakened by a ground shudder and a loud "WHOOM!"

Instantly awake, I was in my boots and on my way to the bunker by the time the second round landed.

While the impact area was 100-150 yards away, these sounded like 122mm rockets.

If you have ever lived through one of these rocket attacks, you know that is still too damn close!

After listening to about three more rounds come in, all was guiet. We waited in the bunker for about another 30 minutes before deciding Charlie had shot all that he had brought that night and that it was safe to go back to bed.

Damn! Three days before leaving Vietnam, and I had been subjected to one more rocket

attack! Would this crap never end?

I slept in until after 7 a.m. the next morning

and made it to breakfast iust before the mess hall closed. Coffee, real scrambled eggs, bacon and toast hit the spot! Now it was time to go get cleared to go home. I went over to the company orderly room just

after 9 a.m. and reported in. It was the morning of Feb. 28, 1969, which meant I had just three full days before I boarded that jet headed back to the real world.

I told the desk sergeant my name and that I was reporting in to be processed back to the USA.

He looked up my records and asked about my time with the 18th MP Brigade. I told him it was miles above staying in the field and sleeping on the ground every night.

He gave me some paperwork and told me to help myself to coffee while he let the captain know I was there.

I poured a cup of black coffee in a reasonably-clean coffee cup and settled in to wait. I had mostly finished my coffee when the desk sergeant's phone rang.

I had not heard that sound for almost a year. He told me the captain would see me now and motioned toward a door labeled "Officer of the Day," instructing me to knock.

"Enter," I heard a voice say, before I opened the door to see one of my former platoon leaders, Lieutenant Ingersoll, now wearing captain's bars.

I noted his promotion and congratulated him before he asked what I had been doing since he saw me last.

I recounted to him about being shot in the head and how that had ultimately led to my TDY assignment with the 18th MP Brigade and the PBR unit at Quin Nhon, ending with the fact I was processing back to civilian life.

Capt. Ingersoll said they had me in the queue to be processed back to the states and asked if I had ever considered staying in the Army? I politely, but firmly, replied, "NO. sir!"

I told him when I was released from service I was going back to school.

We chatted a bit about our time in the 1st of the 8th and some of the missions we completed together. He told me what he knew of my former 1st Squad teammates, which was not a lot.

Finally, he told me I needed to go see the supply sergeant, gave me another typed paper to put in my files and instructed me to get an orderly to take me to Supply.

I saluted and wished him well, before he told me he only had five weeks left in-country himself. That was the last time I would see Capt. Ingersoll.

The desk sergeant got an orderly to take me to Supply. There was one other guy going with us, and we would travel to that area by Jeep, as it was quite a wavs -- almost completely across the compound.

We motored over to the supply tent and found a staff sergeant busy with another guy trying to get processed back home.

He opened a file cabinet and pulled out my supply file. The Army keeps records of everything. After looking through my file, he

told me I had already turned in all my gear about three months ago. I told him about my TDY excursion with the 18th MP unit, and he signed me off as cleared.

I asked him about my personal items lock up and my footlocker, containing the things I had been keeping in the rear area to take home.

He went back to my file and pulled another folder, as I was telling him about the T53 Chinese rifle and the bent-up steel helmet that had saved my life.

When the runner returned with a footlocker with my name stenciled on it, the supply sergeant took a master key from a ring on the desk and opened the locker to reveal it was completely empty.

Someone had taken my shotup steel pot and my Vietnamese compass, along with everything else inside! The only items that had been logged in were the steel pot, the compass and a Marine K-Bar knife from WWII that I had taken off of a VC we had killed in the field

There was no recourse. My war trophies were gone...just gone. But at least I still had the T53 back at the armory, where I would pick it up the next morning when I left An Khe for Cam Ranh Bay -- my point of departure to the world.

The supply sergeant had me sign a paper noting the missing items, stating the locker had been locked and was opened in my presence. I was returned to our orderly room by the Jeep and went to lunch at the Mess Hall.

After lunch I went to the EM Club that opened at 2 p.m. and had a beer while listening to the iukebox. It was actually just a reelto-reel tape player that had come from the PX, but there was some good music that led to me staying for a second beer and talking to anyone that came in.

I eventually made my way back to the transit barracks and wrote the last letter I would write from Vietnam.

I would drop it in the mail the next day, and without a doubt, I would beat it home.

I took a shower and a nap, then returned to the club for a burger and another beer at dinner before heading back to the transit barracks to go to bed.

I turned in around 9:30 p.m. and slept until about 6 a.m. the next morning. Charlie did not interrupt my final night of sleep in An Khe.
