The girl that threw it was screaming that it was piss. It did not smell like urine, and whatever it was soon dried in the terminal's air conditioning.

I walked to the ticket counters looking for an airline that could get me to Orlando or Tallahassee, both were almost an equal distance from my home outside Ocala.

Because American Airlines had done such a good job on the trip home from Vietnam thus far, I decided to just fly with them, as it looked like they could get me there as quickly as anyone else.

I cashed a travel voucher in for a standby seat on a flight leaving for Orlando with a stop in Denver.

Since I had almost two hours before it began to board, I decided to check my duffel bag through to Orlando and walk around the airport terminal for a while, taking in all the sights.

I was really just taking in all of the round-eyed women that were seemingly everywhere I looked. Some were young, some were old, and all the rest were every age in between!

After a year of seeing nothing

but Vietnamese girls, they were all beautiful. To paraphrase the Beatles, "Back in the USSA" and damn proud of it!

I bought a Coke and chips at one of the stands near my gate and took an empty seat in a nearby row of chairs.

About 10 feet across from the row of chairs where I was seated was an identical row facing mine. There were a few folks seated in that grouping, but it was by no means full.

As I was sipping my Coke and snacking on my chips, I noticed a very attractive young lady headed my way. She was carrying a small overnight case and wearing a very short miniskirt.

She took a seat directly opposite mine, placed the case on the floor and put her feet up on it. Miniskirts are interesting in that they barely cover a girl's bottom even while standing. This

girl was not standing -- nor was she covered! I could plainly see her white underwear -- and this girl could really wear them white underwear!

I figured I had just gotten lucky! War protesters and the like of that mob outside never entered my mind. In retrospect, I guess I made it easy for her to spot me, as I was a young guy with short hair still dressed in jungle fatigues. Yeah, that boy had just made it back from Vietnam, and that damn war is all his fault!

The young lady remained seated with her feet up on that case until I worked up enough courage to go over to talk to her.

Now, I had just come back from a war zone, where the enemy had tried for a year to kill me, but they did not scare me any more than she did. When I finally managed to work up the courage to approach her and ask where she was headed, she went berserk. She jumped up and started screaming "Baby killer! Baby killer!" over and over again while pointing at me.

At this moment, I understood instantly what she was all about. Apparently, there were a few protesters that had made their way into the terminal dressed as travelers, carrying small pieces of luggage.

These all seemed to be young women, and most were dressed rather nicely. Even though she was causing a scene screaming at me, I decided not to run away. I guessed that was what she wanted me to do. I simply backed out of her space and let her scream. A small group of people had gathered around to watch her antics. Eventually a uniformed police officer came over and asked her to go with him, which she did.

A man and a woman in their 50's walked over and apologized to me for the girl's behavior. They asked where I was headed, and we talked a little bit about Ocala.

The guy told me he had served in Europe in World War II and had been welcomed as a hero when they all came home. He said that war was popular, and it was supported by most

Americans. He guessed that there were several Americans now who never got behind our effort in Vietnam. Over the next few years, I was to meet several of their kind. We Vietnam veterans soon learned to keep our mouths shut about being in the war. We just never talked about it.
