She usually made something the night before to be reheated the next morning. She told us that there were biscuits from last night in the breadbox and fried sausage patties in the fridge. Dad said he would scramble a few eggs to go with it. By the time we had finished warming everything up on the stove, Mom and Beth

came out fully dressed. The eggs were ready, so everyone made a plate from the stove before sitting down to eat.

"I am leaving for work. David, you can ride in with me and keep the truck for the day," Dad

"I will use the old flatbed because I need to get it ready to haul the cows to the market at Fanning Springs anyway," I said.

thought about some of my high school friends I wanted to look up while I was home. I had not had many close friends while in school, just a couple that I spent time with away from school. My best friend Larry Chambers had gotten married while I was in Vietnam.

My other best friend, Carl Weeks, had been his best man. My sister went to the wedding and had sent me pictures. I wanted to see those guys again before I left for Colorado.

I thought about my friends in Vietnam and wondered what they were doing now. Their day would just be ending, and their supper would probably just be C-rations. I said a silent prayer for them all to come home safe to their mothers just as I had done. I knew that not all of them

I spent my day servicing the old flatbed truck and trailer. We did not use enough fuel on the place to have our own fuel tanks, so I went into the edge of Ocala to fuel up the truck and stopped at the Sonic Drive-In for lunch. The girl turned out to be one of my former schoolmates, Kathy Simmons. I had known her for at least 10 years, as she had been in many of my classes in high school.

Kathy returned several minutes later with her own lunch and got in the truck with me.

"We could get out and set at one of the outside tables and have our lunch," I offered. "I am fine with sitting in the
