I bought a few cabbage plants, but the dang mice ate them last night I suppose. I'm going to invest in a couple of those bucket traps. Still on the lookout for some collards.

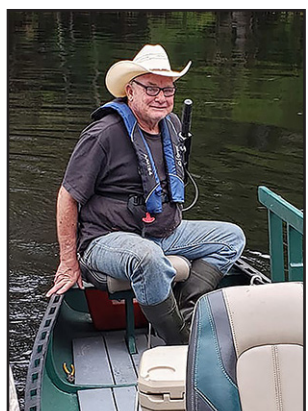

Flood loan deadline is Tuesday

The U.S. Small Business Administration (SBA) is reminding businesses of all sizes, private nonprofit organizations, homeowners and renters in Florida of a Nov. 23 deadline to apply for physical damage disaster loans.

Anyone in the declared counties with damages affected by the severe storms and flooding on Aug. 3-7, 2021, should apply for the low-interest disaster loan program.

The declaration covers Taylor County and the adjacent counties of Dixie, Jefferson, Lafayette and Madison.

Applicants may apply online using the Electronic Loan Application (ELA) via SBA's secure website at DisasterLoanAssistance.sba.gov/ela/s and should apply under SBA declaration # 17194, not for the COVID-19 incident.

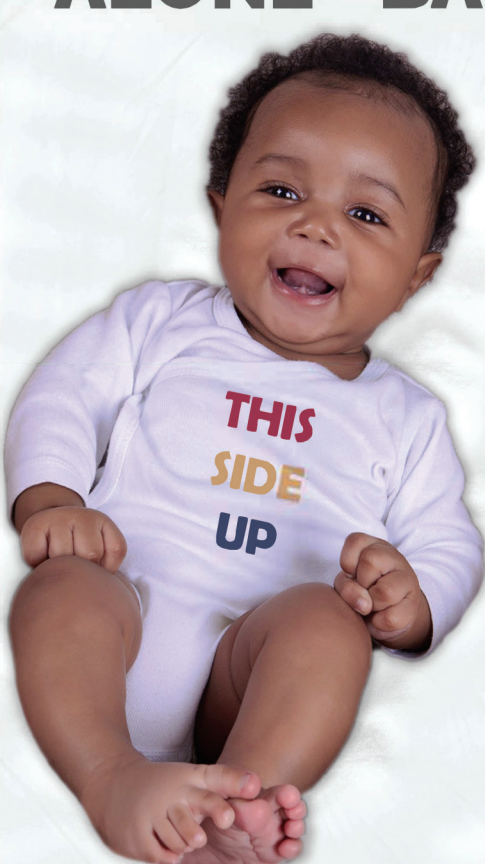
