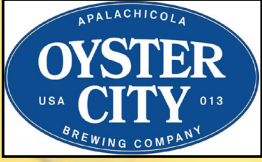




BIG BEND BREWFEST 2022



An estimated 215 people attended Perry's Big Bend Brewfest at Rosehead Park on Saturday, sampling some 50 varieties of craft beer while raising approximately \$8,000 for a pair of local not-for-profit organizations.

Some 14 brewers from across the region were in attendance, pouring up free samples of a wide variety of more than 50 varieties of beer while the crowd listened to music, chewed on pretzels, BBQ and sweet treats.

"I was really glad to see the weather held off for the most part, and we had a really good crowd," said Brewfest organizer Dawn Perez.

A brief shower sent those in attendance under tents, but the beer tasting and socializing continued until the event ended at 8 p.m.

"The crowds really turned out. We had very good attendance – especially considering we were coming off of a two-year hiatus due to COVID – and our numbers were above where we were three years ago," Perez added.

"We got great feedback from the brewers who attended, who all said they would be back and are spreading the word to others in the industry. I think it is safe to say this event is here to stay!" Perez stated.

Danny Aller was one of more than a dozen Tallahassee Beer Society members who made the trip to Perry to take part in the event.

The following day Aller shared with Perez he received some great feedback from one of the brewers who attended.

"The festival went good yesterday. It's not typically one that we would do, due to size and location, but going back and thinking about some of the memories from yesterday, it was just a fun festival," Halpatter Brewing co-founder Jonny Frazier said.

"I think it was the people that made it. A lot of them were trying craft beer for the first time and to see their faces when they drank our beer was really a good experience for us and them," Frazier said.

One of the highlights was when an older "farmer-looking dude" who "looked like he just jumped off the tractor" tried Halpatter's Watermelon Gose for the first time.

"As soon as he tried it, he started laughing and dancing. He carried on for about 30 seconds, and told us how much he enjoyed it," Frazier shared.

"It was probably the best reaction to our beer I've ever seen," he said, adding that one of his beers "literally made an old man dance."

Another highlight was when a Tallahassee Beer Society member ranked Halpatters French Toast Brown Ale as his number one beer out of 442 on the Untappd online beer-ranking app and wanted to get a photo with the Lake City area brewers.

"I think we need to encourage more brewery representation to attend next year to help them grow their festival. You could tell the people putting it on really cared, so I for one am happy we were there to support them," Frazier said.

- Islamorada Brewery and Distillery (No Wake Zone, Coconut Key Lime and Islamorada Citrus Ale),

After expenses, the Big Bend Brewfest raised \$8,000, which will be split between the Perry Rotary Club for student scholarships and the Perry Police Department Foundation.

On the day that Russia invaded Ukraine, you appeared on national television to address this brutal action by Russia and assured the people of the United States that you would take immediate, decisive action to prevent price shock at the fuel pump.

To date, as evidenced by

skyrocketing prices at the fuel pump, this promised action has not taken place.

The news media and you, in a recent press conference, have reported that Russian oil is only 3% of the oil refined in the United States, yet "Big Oil" has blamed the conflict perpetrated by Russia on Ukraine for the

incredible, rapid fuel price increases.

This paltry 3% is not the reason for the incredible fuel price increases in the United States but, as I see it, greed on the part of "Big Oil."

I urge you, as President of the United States of America (POTUS) to take, without delay, the

promised decisive action to prevent price shock at the fuel pump and exercise your authority as POTUS to, if necessary, release reserve oil and direct "big oil" to immediately return fuel prices to pre-Ukraine invasion levels.

In addition, in my opinion, "Big Oil" should

be required to give a cash rebate of \$75 to \$100 to every citizen of the United States for every private vehicle using fossil fuel registered to them on the date of the Russian invasion of Ukraine.
