authorize a temporary trial that uses purchased lime in the water treatment slaker. The Mill proposes to route the existing stationary lime storage hopper to the existing lime bin baghouse. Emissions from the portable lime storage hopper are vented to the bubble scrubber dust collector. The Mill plans to replace one of the truck lines with a line from the stationary lime storage hopper. The emission increases were minimal for this project, 2.14 tons/year of particulate matter, 0.90 tons/year of volatile organic compounds, and 1.92 tons/year of total reduced sulfur. The project did not cause an increase in any emissions of pollutants above the Prevention of Significant Deterioration (PSD) significant emissions rate. Therefore, the project did not trigger PSD review. Permitting Authority: Applications for air construction permits are subject to review in accordance with the provisions of Chapter 403, Florida Statutes (F.S.) and Chapters


