spent 60.2% of the amount budgeted for utilities, 113.6% of the amount budgeted for maintenance, 78.2% of the operational supplies budget and 77.2% of the gas, oil and tire budget.

are departments out there doing a lot of the heavy lifting, with expensive parts, specialty parts, with lots of fuel and big things that get broken," Staffney said.

In individual departments, the hand-out showed the city has already spent 184% of the amount budgeted for vehicle maintenance in the Parks Department, as well as 180% of the vehicle maintenance budget in the Sewer Department, 149% in the

Police Department, 137% in the budget with the in the Fire Department and inflation we saw coming last 135% in the Solid Waste Department.

In the Administrative Department, the city is already over budget (103%) in expenditures for operational supplies.

Staffney pointed out that in all departments in the city's General Fund combined, the vehicle maintenance line item has already spent 97.25% of the budget with five more months still to go in the fiscal year.

In its General Fund, the city has also already spent 72% of the total amount budgeted for operational supplies, as well as 61% of the budgeted amount for utilities and 59% of the total budget for gas, oil and

"I estimated the expenses

summer, but it is starting to spike up above what was put in there for gas, oil and tires and buying parts especially for vehicles," Staffney said.

'We are holding on, but it is a bit dicey right now. Overall, the departments are not far from the 58% mark because they include all the other things, like payroll and insurance, etc., but it is getting a little tight, and I think it is going to continue to get tighter," Staffney added.

In response to a question from Councilman Ward Ketring about projected insurance premium costs, Staffney said those estimates were not yet available.

"We are saving some money buying wholesale, every week," Staffney said.

"I talked to a guy who drives an 18-wheeler semi who said the big tires have gone from \$275 each last year to the high \$700's this year," Ketring said.

"Yes, they have doubled and tripled in price. Luckily we have some in stock that were purchased before this spike, but we have to replace those, and that is going to get us six or eight months down the road,' Staffney replied. "My one-ton chlorine
