**PRIMARY ELECTION - August 23, 2022**

**Book Closing Deadline - July 25, 2022**

The book closing date is the statewide deadline to register to vote or make any party changes. The book closing date for the Primary Election is July 25, 2022. If you need to register to vote or would like to make a party change you may complete a voter registration form and submit it to the elections office or you may choose to register online by visiting our website at [www.taylor-elections.com](http://www.taylor-elections.com) and choosing the Register to Vote link or you may drop by your Supervisor of Elections office located at 433 U S 19 N, Perry, Florida 32347, on or before this book closing date. Once the registration books close, only updates to a voter's name, address and signature shall be permitted.

Florida is a CLOSED PRIMARY state, and therefore in a primary election, voters may only vote for candidates in their party of registration. By not selecting a party when you register, your vote is limited in the primaries to nonpartisan races and issues. The only exception to this is a Universal Primary Contest or "UPC". A Universal Primary Contest is a contest in a primary election in which all candidates have the same party affiliation, and the winner will have no opposition in the general election. All qualified electors in the district that race represents may vote on a Universal Primary Contest regardless of party affiliation.

**VOTE BY MAIL BALLOTS**

Any registered voter may request a mail ballot. Request can be accepted only from the voter, a member of the voter's immediate family or legal guardian. Please call the elections office at 850-838-3515 to request a mail ballot. The Supervisor of Elections office will begin mailing ballots to all domestic voters who have made a request on July 14, 2022. The last date to request a ballot to be mailed for the August Primary is Saturday, August 13, 2022, at 5:00 p.m.

**ELECCION PRIMARIA - 23 de agosto de 2022**

**Fecha Límite de Cierre del Libro 25 de julio de 2022**

La fecha de cierre del libro es la fecha límite en todo el estado para registrarse para votar o realizar cualquier cambio de partido. La fecha de cierre del libro para la Elección Primaria es el 25 de julio de 2022. Si Usted necesita registrarse para votar o desea hacer un cambio de partido, Usted puede completar una Solicitud De Inscripción de Votante y enviarla a la oficina de elecciones o puede optar por registrarse en línea visitando nuestro sitio web [www.taylor-elections.com](http://www.taylor-elections.com) y eligiendo el enlace Registrarse para Votar, o Usted puede pasar por la oficina Supervisora de Elecciones ubicada en el 433 U S 19 N, Perry, Florida 32347; en esta fecha de cierre del libro o antes. Una vez que se cierran los libros de registro, sólo se permitirán actualizaciones del nombre, dirección, y firma del votante.

Florida es un estado PRIMARIO CERRADO y, por lo tanto, en una elección primaria, los votantes pueden votar solamente por candidatos en su partido de registro. Al no seleccionar un partido cuando se registra, su voto en las primarias está limitado a las contiendas y asuntos no partidistas. La única excepción a esto es una Contienda Primaria Universal, o "UPC" por sus siglas en inglés. Una Contienda Primaria Universal es una contienda en una elección primaria en la que todos los candidatos tienen la misma afiliación partidista y el ganador no tendrá oposición en las elecciones generales. Todos los electores calificados en el distrito que representa esa contienda pueden votar en una Contienda Primaria Universal, independientemente del partido de afiliación.

**BOLETAS DE VOTO POR CORREO**

Cualquier votante registrado puede solicitar una boleta por correo. Las solicitudes pueden ser aceptadas solamente de parte del votante, un miembro inmediato de la familia del votante, o un tutor legal. Por favor, llame a la oficina Supervisora de Elecciones al 850-838-3515 para solicitar una boleta por correo. La oficina Supervisora de Elecciones comenzará a enviar boletas por correo a todos los votantes nacionales que hayan realizado una solicitud, el 14 de julio de 2022. La última fecha para solicitar una boleta para ser enviada por correo para la Primaria de Agosto es el sábado 13 de agosto de 2022, a las 5:00 p.m.

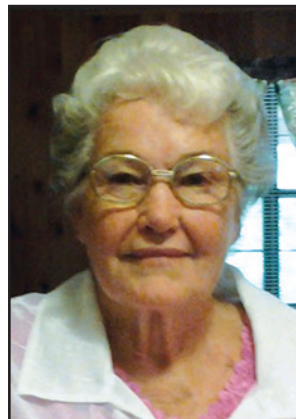

Grubbs, and five brothers, Billy Grubbs, Herbert Grubbs, Robert Grubbs, Jerry Grubbs and Tom Grubbs.

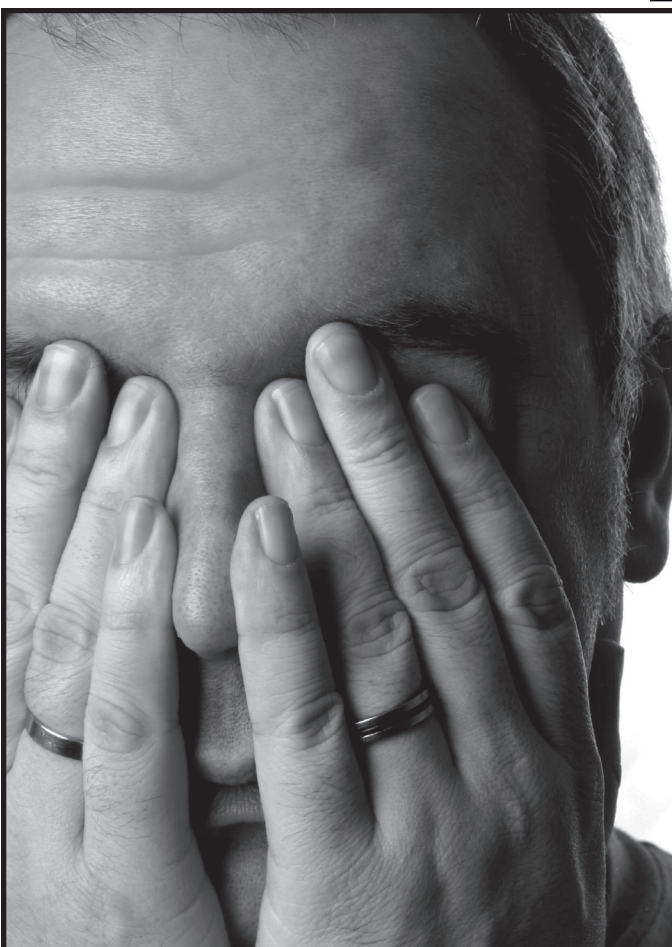
