## Brynes, Hart agree to starting salary during meeting

the top candidate before bringing back a proposed contract to the full council for approval.

Brynes began discussion by stating, "We are about to perform one of the most important jobs we've got as a council. We met for 30 minutes with each, and then we met with them as a group. This is the information that I gathered out of it."

"During his initial 30-minute interview, I was told who he knew, who he meets with, representatives...a lot of name dropping. He stated he already has people working on getting the city money. If I was hiring someone to do a lot of puffing, Travis would be at the top." - City Councilman

"Lawrence McNaul has the knowledge and experience to run this city, including utilities. Looking at his information, every one of us should say he's number one," Brynes said. "But, he has been in a number of job searches over the last five years. He said that. And right now he's a finalist, or semi finalist, in Fort Walton or Palatka and was a finalist in Panama City Beach." Brynes stated

McNaul's expected salary range would be "\$115,000 to \$130,000." "I asked the question,

have you ever been fired or resigned under pressure from a job? The answer was no. The answer was less than truthful," Brynes alleged, pointing out McNaul also failed to complete the application as requested.

"On June 22, 2016 there was two votes to fire him and two no votes. And, a new member of the council voted to keep him and give him six months to change,"

Brynes stated. "At a Jan. 5 (Hardee County) Board of County Commission meeting, he submitted his resignation effective March 3, but the board made it effective

"I met with Travis Coker. I've served with him on the DMH Hospital Board. He didn't put up a whole lot of fuss on the board...he was there," Brynes stated.

"But, if you look back, he has been at this (current) job for five years, but then he was at one for four years, then 10, three, one, three, three, two, less than one, two," Brynes said.

"In a discussion he had with a group of us at the hospital, he said he never planned to stay anywhere more than five years," Brynes stated.

"His present salary is \$101,000 plus bonuses, and he said he would expect to make what he makes now, but he never said what that was," Brynes added. "He said he had been fired twice, but gave no explanation."

Brynes stated, "John owned and operated a business. He was self-employed until he sold the business, and then he spent a year staying on to help the new owners.'

"He had employees out there. He knows what it is to have to make a payroll. I speak for myself, sometimes we didn't have money to make payroll, so we went and knocked on doors and collected money so we could meet payroll. That is a business," Brynes added.

"After he got out of school, he worked with GP the entire time. He expressed a lot of the needs of the city...new technology and reviewed city documents. When questioned about salary, he said this was not about salary, but the desire to help the City of Perry move forward," Brynes stated.

"I asked him a number of times about salary, and got the same answer, 'it is not about salary'," Brynes said.

"It would be a good, good thing if the City of Perry had an engineer. Not a civil engineer to do this, this or this, but for what they got up here (pointing to his head). It would be very beneficial for the City Brynes said.

"Looking candidate, I would have to say John has the most to offer to the City of Perry," Brynes concluded.

"I've had numerous people ask me, well, who is going to be our next manager?" Landry began. "I told them I'm not making a decision until I have interviewed the candidates. I don't think that's fair. Even though two of them are from our hometown. You need to talk to them and get to know them a little bit. And I did," Landry said.

"When I ran for this office, I promised people that I would vote my conscience, and my conscience tells me that John Hart would best serve this position," Landry concluded. Councilwoman Venita

Woodfaulk was next to speak, beginning with, "OK, Mr. McNaul...I have nothing to say." "Mr. Coker...So, he's a good dude. Loved our

Councilman Ward Ketring began by stating, "Mr. McNaul....scratch."

"However, at the end of the day I've come to lean toward – as far as the overall operation and running the city - I tend to lean toward Travis Coker," Ketring said.

"I wish I could hire Mr. McNaul, but -- there's a but -- so I'm gonna leave that be," Hampton said.

After expressing she was "torn between Mr. Hart and Mr. Coker," Hampton asked, "So, what do we do now?" before stating that she was casting votes for both Hart and Coker, which she said would give Hart a total of four votes and Coker two

After Curtis clarified Hampton could not vote for both candidates, Brynes made a motion to enter into negotiations with Hart. During the roll call

vote, Brynes, Landry and Woodfaulk voted in favor of Brynes' motion, while Ketring voted against.

Hampton took several minutes to decide, before finally announcing her "no" vote, which meant Brynes' motion passed by a 3-2 margin.

Curtis asked for guidance from the council negotiating the starting salary, stating he and the mayor (Hampton) would meet with Hart and bring back a proposal.

However, Brynes quickly stated, "\$85,000 with six months probation and then \$95,000."

When Curtis asked for input from other council members, he did not receive

"It is also good for the candidate to hear that is what the council expects us to be negotiating around," Curtis

Finance Director Penny Staffney shared that the city's current budget has City Manager Taylor Brown's base salary at \$110,000, not including a \$5,600 car allowance and an "incentive bonus, since he didn't use the health insurance."

Several council members stated they objected to a car allowance going forward, stating that the city would pay mileage or provide a city car. "You are not paying

Florida Retirement System (FRS) on the car and the incentive, so that comes to about \$137,000 or \$138,000 what is budgeted," Staffney said.

"Would you accept \$85,000?" Brynes shouted across the room directly to

I was welcoming Mr. Hart to the board and if everything works out with the contracts and everything is done the way he wants, I am looking forward...I wish we could have both of you," Ketring said to Coker.

They both were very good candidates," Woodfaulk agreed. "The very best (candidate)
