FWC: Hurst killed 30+ turkeys in '21 spring season

Continued from page 1 work provided evidence

that Hurst had far exceeded the season bag limit of two wild turkeys per person and had killed more than 30 birds during the spring 2021 season.

Evidence also showed Hurst killed several gobblers illegally during the closed season. The investigation in Spring 2021 provided evidence that he had also committed armed trespass on multiple occasions in four Florida counties.

Hurst didn't stop at

Evidence showed he harvested more than the season bag limit for deer (five deer per person) during the 2020-21 deer

In fact, Hurst likely harvested 20 bucks during the 2020-21 general gun season, investigators said.

Due to Hurst's poaching

activities in 2020 and 2021, FWC investigations extended the investigation into the Spring 2022 season. Additional evidence was

collected that Hurst had far exceeded the season bag limit for turkeys, killing at least 15 birds in the wild turkeys, investigators 2022 season. Additional

evidence was collected to further solidify cases of armed trespass in multiple jurisdictions and several gobblers poached during the closed season.

"Over the course of the investigation, we were shocked by the egregious nature of both Hurst's illegal exploits and his social media posts," said FWC Deputy Director of North Operations Lt. Col. Gregg Eason. "He bragged about the number of wild turkeys he poached, often trespassing to do so, and his ability to elude law enforcement."

On Sept. 20, 2022, FWC

officers executed search warrants at Hurst's house in Taylor County and a hunting camp in Lafayette County.

Two shotguns, Hurst's iPhone, 156 pairs of turkey feet/spurs, 155 turkey beards and 21 sets of deer antlers were seized during the searches.

Investigators on the case were assisted by numerous FWC officers, along with law enforcement officers from partner agencies.

The FWC's pursuit of this wild turkey poacher over the span of a twoyear investigation speaks to the dedication to the

wild turkeys in Florida are plentiful for future generations to enjoy.

"If it hadn't been for members of the public and hunters who saw something wrong reported it, there's a chance this individual could have continued abusing our state's natural resources well into the future," said FWC North Central Regional Commander

wildlife laws are in place to ensure resources exist for the enjoyment of future generations and Hurst has shown nothing but disrespect to the land, the resource and law-abiding hunters."

Charges were filed in Highlands County to be prosecuted by the Office of Statewide Prosecutor, and judicial proceedings are pending.

time served as acting city manager.

The budget amendment approved by the council during the Feb. 14 meeting transferred \$3,322 from city's wastewater executive salary budget line item to cover one month of increased salary and benefits for Cruse.

"I come from a different time period in this world, so keep that in mind, but it is normal to ask an employee to perform additional duties outside of their normal job. What is not normal is to pick and choose which employees you are going to pay," Brynes said.

example, have an employee out on disability in the wastewater department, and we have

another employee in the sewer department. You have to have a license from the state of Florida to operate the sewer department and a license to operate the water plant. We have an employee who has a license to operate both the water and the sewer plant," Brynes said.

"While the one is out on disability - I believe it has been for eight months -- here is someone that is picking up both jobs as you should when you work for an employer," Brynes added. "And, so we are going to increase these (PPD) salaries, but the decision was made not to increase that (the other employee's salary)."

"But, this employee wanted to do it for the city. He chose to do it to help the city and help this other employee out in case he could come back to work,' Brynes said.

"The city needed help. employer needed help, and the employee was a good employee who stepped up at no additional cost to the city, which, in my opinion, is the way things should be. I cannot support this one bit. Treat people the same," Brynes stated.

"I can go along with you on that, Bill, except that the chief is not where he ought to be anyway," Councilwoman Diane Landry replied.

"Yes he is." Brynes shot back. "Now you are stepping into administration."

"Who is stepping into administration?" Landry asked.

"You are, when you are talking about doing that. That is the city manager's job. In his (Cruse's) opinion,

he is not where he ought to be (in salary)," Brynes said.

"And, we said we would handle that at budget time," Landry responded.

"You are still stepping over the city manager,' Brynes stated.

"No, we said we would do it with the city manager's input at budget time,' Landry replied.

"You have no idea what that input will be, so you can't make a promise, in my mind, that you should not be making," Brynes added.

"You may have people working in the water plant today who may be picking up trash tomorrow. They all float and move," Brynes stated. "We never hear 'I've got to have more money' when asked to step up."

On a motion by Ketring and a second by Woodfaulk, the council voted 4-1 in favor of the budget transfer to cover a temporary onemonth bonus for Cruse.
