On October 28, 2022, the Commissioner of Agriculture received a letter from the Florida Department of Economic Opportunity declaring the Taylor Soil and Water Conservation District inactive pursuant to section 189.062(1) (a)1. and 2., Florida Statutes. The Inspector General of the Department of Agriculture and Consumer Services Pursuant to Section 582.30(3)(b) has subsequently confirmed that the Taylor Soil and Water Conservation District has failed to comply with the audit and financial reporting requirements of Chapter 189, Florida Statutes.
