Draft Goldwater Rally Success

This summer marks the 60th anniversary of the historic "National Draft Goldwater for President Rally" in Washington D.C.

Young enthusiasts for Barry Goldwater, a U.S. senator from Arizona, assembled for a rally on July 4, 1963, at the country's capital in the non-air conditioned National Guard Armory, with an overflow crowd of over 9,000 young people.

Goldwater had built up a lot of political support as an advocate for individual rights, the U.S. Constitution and local control.

The 4th of July is probably the worst day of the year to stage any kind of mass meeting in that city. When the calendar turns to July, Washington roasts every year from the unrelenting heat and humidity. As a rule, there is a mass exodus

from Washington, not an ingathering, for this holiday. **America First Rally**

The rally featured Hollywood stars Walter Brennan, William Lundigan, Chill Wills and Efrem Zimbalist, Jr.

Of the political notables lined up for the draft Goldwater rally, there were Governor Paul Fannin of Arizona, Sen. Carl Curtis of Nebraska, Sen. John Tower from Texas and Congressman John Ashbrook of Ohio.

About 8 p.m. on that July 4th pandemonium broke loose. As described in his book documenting the campaign, titled Suite 3505, F. Clifton White wrote: "the Trophy Room opened and a group of Goldwater Girls outfitted in Western straw hats escorted organizers speakers' onto the

seated only 6,500, but somehow more than 9,000 people had jammed themselves inside. Someone whispered that the fire marshals had closed the doors, leaving several thousands more stranded in the street.

The master of ceremonies, Peter O'Donnell from Texas, told the crowd: "You and dedicated people like you in every state of the union are beginning to write a new chapter in American political history. We are embarking on a great crusade together. This evening marks the first step toward our goal - to put Goldwater in and (John) Kennedy out.

There are people here from 44 states, including big delegations from New York, Pennsylvania and, very significantly, Massachusetts. This is proof positive that Kennedy does not have the big states

signed, sealed and delivered, no matter what the corrupt big-city machine politicians tell the Kennedys."

North Florida

The 1964 United States presidential election in Florida had Lyndon B. Johnson, incumbent candidate for president, nose out Barry Goldwater, 948,540 (51.15%) 905,941 (48.85%).

The struggle initiated on that 4th of July, 1963, Draft Goldwater Rally has had huge consequences for Florida. That struggle was waged in 1964 in the hills and fertile valleys of the state -- and just look at the results!

It was the first time ever that Bay County, Franklin County, Gulf County, Lafayette County, Liberty County, Suwannee County, Taylor County and Wakulla County ever voted Republican.

It was the first time since

1872 that Jackson County and Columbia County voted Republican and the first time since 1884 that Leon Republican County, Jefferson County and Madison County voted Republican.

And, since the presidential election of 2000, Madison County has voted for the candidate with an ever increasing margin each and every four
