against the proposed rules, stating that they properly moored their boats prior to the hurricane, adding that they felt it was unfair to punish them when their boats only came loose after being struck by other debris, namely dumpsters, docks and boat houses that were washed upstream by the storm.

Several other Taylor County commissioners said they could see both sides of the issue and were not ready to make a change. The board is expected to return to the discussion on mooring boats in the river at its next workshop on Tuesday, Oct. 24.

Newman started the discussion by showing photos of the boats striking the bridge during the storm, stating that the Florida Department of Transportation (FDOT) determined the bridge was not damaged enough by the impacts to close the bridge.

However, Newman also noted that the bridge contains water and sewer infrastructure that could be damaged in the future should a similar event happen again.

"My understanding is there is a (Florida) statute that will allow the county to bring forth an ordinance in respect to anchoring limitation areas," Newman said. "Seeing the ongoing threats to multiple areas, whether that be infrastructure, whether that be private property, whether that be business, commerce or our environment. We see and understand and recognize that the threats are growing and are quite costly.

"It just seems to me like a practical and commonsense time to bring that forward," Newman said. County Administrator

LaWanda Pemberton said Dixie County's attorney reached out to Taylor County Attorney Conrad Bishop in 2017 regarding the possibility of establishing a mooring area in the river.

"I cannot recall if that was easier to enforce than not allowing any mooring at all in the river," Pemberton said. "Shortly after that, we reached out to [the Florida Fish and Wildlife Conservation Commission (FWC)] and really did not get, from what I understand, real direction as far as enforcement.

"I'm not sure which direction the board wishes to go," she said.

Newman said it was his opinion that if the county were to pass regulations, "the goal would be eliminate this kind of threat at all," including potentially banning mooring altogether in the river.

O'Steen said he inspected the bridge himself, along with FDOT, after the storm, noting that "two masts had knocked two chunks" out of the bridge.

"I'm for removing them all," he said. "Whatever we need to do to get them out of that river, I'm all for it. We're having these storms more and more often. They're going to destroy people's property. They may go through someone's house and kill somebody like that. You're got people living on them. Most of them are on my side of the river, and I'm ready for them to be gone."

Newman asked if the board was willing to allow Bishop to research Florida Statutes regarding mooring restrictions.

"They could legally stay out in the Gulf anywhere they wanted to out there," Commissioner Jim Moody said.

Dixie County resident David Jensen, who rode out Idalia with his wife, Kinks Evans, on board their 65foot boat in Deadman's Bay, countered that the

attorney reached out to boats were not the primary Taylor County Attorney threat.

"I'm sorry to say, it wasn't the sailboats that caused your damage," Jensen said. "It was the docks that were improperly took care of that came up that river and knocked us free. We took three days, four days to make sure our boats were secure. But when you have a tidal surge of that mass that rips entire dock houses out and wipes them into us, what do you think is going to happen to us?

"Every one of my boats in that river has been registered, properly moored, properly maintained," he said. "It didn't stop it. The only thing that stopped the Scintalla was me and my wife on that boat for three-and-a-half to four hours motoring it, dodging dumpsters, picnic tables, floating docks. We watched a three-bay dock float right by and into your so-called neighbors' house. Who is taking care of that responsibility?"

Jensen said he had three boats in the river, and two of them were among those that went under the bridge.

"I understand the damage to the bridge, and I feel for that, but you can't lay blame on all those folks," he said. "Not when people are out there rebuilding docks without permits, putting unregistered floats under those docks. You want to prosecute one without the other."

Jensen said one of his boats was attached to a dock that was taken out by another dock that came loose.

"There are constitutional rights given to us, whether we have boats or houses," Jensen said. "That boat of mine is my house, my dwelling, my everything. You take that away from me, you put me on the street with the homeless. What gives you that right?"

Also addressing the commission was Robert

Dixie County Commissioner David O'Steen said the strikes resulted in "two chunks" being taken off the bridge. "I'm for removing them all," O'Steen said at the Taylor County Commission's recent workshop. "Whatever we need to do to get them out of that river, I'm all for it."

"Cricket" Watson, pastor at Antioch Revival Center Church, who said he was there representing Islander Evangelistic Ministries (IEM), which carries humanitarian aid to Haiti via its mission sailboats. The non-profit organization has two boats stationed in Steinhatchee.

"The biggest problem we have (in Steinhatchee) is derelict boats," Watson said, noting that Florida Statutes already dictate procedures for removing derelict boats, adding that FWC has grants available to remove such boats.

"I don't think it's fair to punish us who keep our boats up to code," he said. "None of us can help a Category 3 storm. There were garbage dumpsters going down the river. What are we going to do? Remove all the garbage dumpsters in Steinhatchee? There were docks going down the river, boat houses going down the river," Watson said.

Next to speak was IEW Lead Captain Raymond Bideaux, who said they have had two vessels in Steinhatchee for 20 years.

"We had them on a dock for a long time, and the owner of the dock sold out

and moved out of state," Bideaux said. "Especially around scallop season, you're not going to find dock space for a 50-foot sailboat, so we had to go to the river.

"We've got an area of the river where the current wasn't so bad," he said. "I'd say we had 4,000 to 5,000 pounds of weight on the boat. When this hurricane came through this last time, we were all there prepping the vessel, making sure we had plenty of weight down, tied off to the woods, whatever we thought we could do to keep the boats in position.

"On our flagship, we had five sailboats, a dock and a garbage dumpster piled up on it," Bideaux said. "The mooring held. It dragged until it caught. That video has become famous, all those boats going underneath the bridge. They came off our flagship, because the flagship hung and then turned, and they all came off.

"The bottom line is, some of us really went to great measures to make sure we had plenty of weight down," he said.

Bideaux alleged that a large dock measuring some 75 feet long broke loose

near Roy's Restaurant, starting a "domino effect," sending the other boats and docks upstream to eventually impact their flagship.

"In a perfect world, everybody would take responsibility," Commissioner Pam Feagle said, suggesting people should have moved their boats out of the path of Idalia due to the amount of warning they had prior to the storm's arrival.

"I understand what you people are saying, and I don't really know the answer right now," she said. "I'm trying to look at both sides. I think the easy thing to say right now is to get the boats out. That's the easy way.

"I don't know where I'm at with this issue," Feagle said. "I don't have a firm position."

"I'm with Commissioner Feagle," said Commission Chair Jamie English. "I don't know where I'm at with this."

At the end of the discussion, Newman again asked Bishop to research Florida Statutes, and the board agreed to resume discussion on the issue at its Oct. 24 workshop.
