# **Century seeking Steinhatchee business** where they can store their oxygen tanks

"What it comes down to is this. We appreciate the efforts of Century Ambulance and their service to our residents, but to be absolutely clear, we obviously have an expectation of that service throughout the county," Newman said. "This particular instance was down at Station 7 in Steinhatchee, where there is an assigned truck. We would just continue to emphasize to Century that those residents down there are far and away, and we have an expectation that that truck is going to be available and in that service area."

"On April 24, we had our Steinhatchee unit, which had to come to Perry to resupply with oxygen," said Maymon, who noted that the oxygen is stored in a large "H tank" on board the ambulance.

other things like that we carry on board," he said. "These tanks contain 2,000 pounds of oxygen. This tank was down to just a tad under 900 pounds. "There was a shift change that morning. and when there's a shift change, of course, the entire ambulance is gone through, and the paramedic who was in charge for the day always checks the oxygen level. So, he made a decision -- and not a bad decision, mind you -- that the tank needed to be changed out.

go to Gainesville, we could have made it, but it would have been tight," Maymon said. "So, he requested permission from the onduty supervisor to come up to Perry and change his tank out. He did that.

"Shortly after he went en route, there was a call that came into the Perry area," he said. "We dispatched local Perry units to the call. I want to give you exact times. At 10:56 a.m., as the first Perry unit was about to clear, although they were still engaged with the patient at the hospital, another call came in. The Steinhatchee unit was here, changing their oxygen.

"At 11:08 a.m., we received a request for service in Steinhatchee,' Maymon said, adding that due to HIPPA, he would not discuss the medical nature of any of the calls.

"So, we dispatched the unit from Perry at 11:08 to Steinhatchee, and we arrived at 11:37, for a total into," Commissioner Pam "It drives ventilators and of a 29-minute response Feagle said. "We had a lifetime," he said. Maymon said Century normally would have stationed one of the Perry units at a designated halfway point (located at Krazy Keaton/Walter B's on Beach Road) while the Steinhatchee unit was in Perry resupplying its oxygen, as this is what occurs whenever the Steinhatchee unit is transporting a patient to Gainesville.

second of which came in before the first unit had completed its response, necessitating the second unit to respond.

"I am sorry for the long response time, and I feel for the patient and the family," Maymon said. "I understand that there are some folks down in Steinhatchee who are very upset, and I understand that. "There are going to be

times when we have to resupply the unit," he said.

Maymon explained that the Steinhatchee fire station, where the ambulance is stationed, is raised off the ground, which precludes them from storing oxygen in the building. He added that they do keep other supplies at the fire station to restock the ambulance as needed.

"I hear what you are saying about bringing the truck up for the O2 tank, and to me, that's not an excuse that I can buy threatening injury, and just by the grace of God this person survived. It was a long time before they got to Shands (in Gainesville). What I expect you to do is find out another way to get that oxygen," Feagle said. "So, if they can't lift it up into the building, what's to say that some kind of vehicle can't deliver that -- even if you have to pay a delivery service -- so you don't have to take that ambulance out of service.

of things could happen on that water and on the road. So, you need to figure out something so this doesn't happen again," Feagle said.

Maymon noted a license is required to store oxygen tanks, but he said that he would look for another location in Steinhatchee -- ideally a business that already uses oxygen that would be secure and already licensed. He added that they would be willing to pay rent for storing the oxygen there.

"If that's what works, then that's fine with me," Feagle said. "My only point is this. You have to figure out a way that that ambulance is not taken out of service to come to get supplies and leave that many people down there without coverage."

Commission Chair Jamie English asked how often the oxygen tank needs to be replaced in the ambulance, and Maymon said it varies, noting that they could go a month without an issue, but а ventilator is required (which uses the largest amount of oxygen) could bring levels low enough to necessitate a replacement.

"You just need contacts for business locations, right?" Newman asked.

We operate very geographically in a lot of counties, and in a lot of counties, I only have oxygen supply in one location. Newman reiterated that the oxygen issue could be rectified by partnering with a business in Steinhatchee to store it securely.

"Yes, sir," Maymon said. Feagle asked that the county receive an update by the end of the week.

"Time is of the essence," she said.
