## Southerland re-elected unopposed for the fourth election in a row; third consecutive time Wiggins without a challenger

races concluded on Friday, June 14, at 12 noon, with eight incumbents facing challengers.

City qualifying ended on Monday, June 10, with one race going to the polls. Local voters will have the chance to decide who wins those races in the Aug. 20 primary (see related story).

Bv receiving challengers, Dunnell earned a third term in office that will begin this November.

She was first elected in 2016, unseating seven-term school board representative Kenneth Dennis to claim the Dist. 5 seat. In that election, Dunnell received 52% of the vote -- enough to forgo a run-off -- over Dennis, who received 29% and fellow challenger

"Nate" no Thomas Gray (18.76%). Four years later, Dunnell won re-election against challenger Daniel "Dan" Chaney.

Knowles, along with the other constitutional officers, will begin his second term as the county's clerk of court in January.

He was first elected in 2020, defeating fellow Republican Mike Hunter. veteran He succeeded

Clerk of Court Annie Mae Murphy, who announced her intention to retire after serving nine terms and endorsed Knowles. Murphy died two months before her final term was to end, and Knowles was appointed to serve as interim clerk before beginning his first term.

Southerland earned her fourth consecutive term unopposed and fifth overall term in office as supervisor

of elections.

She first won her office in 2008, defeating fellow challenger Abbey Lundy Tharpe to succeed Molly Hendry Lilliott (1997-2008). Southerland then won re-election unopposed in 2012, 2016 and 2020 before doing so again this year.

Finally, Wiggins earned his fourth term in office as county tax collector.

He first won election in 2012, defeating fellow challenger Randy Hathcock to succeed retiring Tax Collector Jack Tedder. Wiggins served the previous six years on the Taylor Commission. County resigning two years into his second term to run for tax collector. Wiggins was re-elected tax collector unopposed in 2016, 2020 and again this year.

county-wide depending on the race -- will be able to vote in those races.

The nonpartisan races include those for Taylor County Judge, Taylor County School Board District 3 and Perry City Council District 3.

The race for county judge will feature incumbent Judge Bill Blue and challenger Angela Ball.

Incumbent School Board member Jeanne E. Mathis (District 3) will face challenger Laurel Hendry LaValle, while Incumbent Councilwoman Citv (District 3) Diane Landry will face challenger Willie Jefferson Anderson Jr.

Nonpartisan races can go to a runoff to be decided in November if there are more than two candidates and no one receives more than 50% of the vote, but since there are only two candidates in each race, all three will be decided in the primary election.

As for the remaining local races, all of the candidates are registered Republicans with as

the exception of Taylor incumbent Commissioner County Thomas Demps (District 5) and challenger Ocie Reaves (both registered Democrats).

all Since of the candidates in each race are in the same party, they will all be decided in universal primaries in which all registered voters will be eligible to vote. However, unlike nonpartisan races, there are no runoffs, even if no candidate in a particular to vote in the race for race receives more than 50% of the vote.

Incumbent Taylor County Commissioner Jamie W. English (District 1) and challenger Justin K. Webb;

 Incumbent Taylor County Commissioner Michael Elzie Newman (District 3) and challengers Michael Anthony Green, Ursula Miller and Robert Shannon Millinor;

• Incumbent Taylor Commissioner County Thomas Demps (District 5) and challenger Ocie Reaves.

In addition to the local races for public office, Taylor County Republicans will also have the chance state committeeman, a county-wide party position, between Dustin Beach and Earl Swann.

There was also set to be race between Shawna Beach and Ann-Marie Dosher for state committeewoman, but Dosher withdrew from the race prior to the conclusion of the qualifying period.

There are also committeeman and committeewoman positions in each voting precinct, with Christy Moody (committeewoman, Precinct 2) and Patricia K. Coker (committeewoman, Precinct 14) winning unopposed.

The Democrat party has identical positions on the county and precinct level, but no one filed to run for those seats.

Meanwhile, in the race for U.S Senate, a total of 11 candidates qualified to run this year, including three Republicans and four Democrats.

In the August primary, Republican voters will choose between incumbent U.S. Senator Rick Scott and challengers John S. Columbus and Keith Gross, while Democrat voters will choose between challengers Stanley Campbell, Rod Joseph, Debbie Mucarsel-Powell and Brian Rush.

The remaining candidates, which include one write-in candidate, one Libertarian and two with no party affiliation, will move on to the November general election.

As for the race for the U.S. Representative District 2 seat, Republicans will vote in the primary for either incumbent Neal Dunn or challenger Rhonda Woodward. Democrat voters will have to wait until November, as there was only one Democrat challenger, Meghann Hovey, who qualified for the race.

In the race for the State Senate District 3 seat,
