consideration. local Last year, commissioners, citing the focus on Taylor County after Hurricane Idalia and the closure of Georgia-Pacific's Foley Cellulose mill, requested a large number of items and received partial funding for several in the state budget.

That funding included \$2.5 million toward a \$20 proposed million Taylor County Public Safety Complex, \$525,000 for replacement of 911 equipment, \$500,000 toward the planned replacement of the Steinhatchee fire station (adding to \$1 million previously received), \$125,000 for the Taylor Development County Authority (TCDA) and \$10,500 for a generator at the Taylor County Public Works Department.

The funding was half of what the county had requested for the fire station, TCDA and generator funding.

In addition to the direct allocations, the county remaining funding for the to fully staff the Perry, not heard any indications

also received two Florida Recreation Development Assistance Program (FRDAP) grants through the Florida Department Environmental of Protection (FDEP), including \$124,830 for improvements to Southside Park and \$200,000 for the Horseman's Arena.

In her letter, Feagle stated her funding requests this year were, in order of priority, the full remaining amount needed for the EOC, Keaton Beach fire station, Shady Grove fire station and a new animal shelter.

Feagle stated she suggested ranking the Keaton Beach fire station ahead of Shady Grove, which has already received \$1 million (half of the projected cost), due to the fact that it is currently home to paid firefighters.

County Grants Writer Melody Cox stated that with the Southside Park and Horseman's Arena projects, the county is currently "maxed out" with the FRDAP program.

public works generator, as well as a generator for the courthouse, would be covered through the Hazard Mitigation Grant Program.

As for the EOC, Cox said it was suggested to her by state officials to request the funding in phases, rather than asking for the full amount at one time.

She suggested requesting \$7.5 million, which would bring the county's total of construction funding up to \$10 million.

Commission Chair Jamie English said his preferred project ranking would be the EOC, the Keaton Beach station, the courthouse air handlers, the arena and then the Shady Grove station.

"I'm not trying to put Shady Grove fire off, but right now, we know we can't staff it," English said. "We're struggling to staff the other stations we have."

Taylor County Fire-Rescue Chief Dan Cassel recently addressed the commission, stating that due to several employees leaving for jobs elsewhere, the county may soon not have enough firefighters

Steinhatchee and Keaton Beach stations, leading to potential "brownouts" in which the Keaton Beach station might have to be occasionally closed.

As for a new animal shelter, English asked Pemberton if staff had a cost estimate, and she said Director Environmental Services Gary Wambolt has roughly estimated it would be around \$400,000 for a new metal building.

"We were here the other night, and kind of figured out that we don't know if we really have a problem (with Animal Control)," English said, referring to an hour-long discussion with shelter volunteers at the board's Oct. 29 workshop (see related story).

"We had a bunch of finger pointing, but when we got right down to it, and everybody was sitting down in a room together, we really didn't have a problem, other than people's personal feelings," English said.

Commissioner Michael Newman added that based on updates from staff and department heads, he had that a new shelter was needed.

"In all fairness to our department heads, unless there is a major deficit, I doubt anyone would ask for a new building just knowing how tight the budget is,' Pemberton said.

English noted that his opinion when it comes to legislative requests is to "ask for it all."

"My question is what stipulates this is a necessity when we just had all of these discussions?" Newman asked of the "We're animal shelter. not out of compliance. We're not having problems staying within the statutes. And, now we're seeking an appropriations request for a brand new facility."

Commissioner Thomas Demps said he would prefer seeing requests in the area of economic development instead of the shelter, and Pemberton said that the TCDA made its own legislative request last year that resulted in the \$125,000 it received.

Near the end of the discussion, Pemberton noted that staff

engineered the proposed parking lot improvements at Forest Capital Hall, and the projected price was \$411,000 – which was significantly higher than what they had originally thought it would be.

Cox suggested rolling that amount into the \$1 million they were planning to request for Agricultural and the Exposition Center project, which would include the construction of a steel covering over the arena to covert it into a facility that has the capabilities to host agricultural and livestock events.

Ultimately, Newman made a motion to submit the following projects, in order of priority:

1.) EOC (\$7.5 million),

2.) Keaton Beach fire station (\$2 million), 3.) Courthouse air

handlers (\$1.5 million), 4.) Agricultural and

Exposition Center (\$1.4 million),

5.) Shady Grove fire station (\$1 million).

Officer, I can give you paperwork to fill out to try to get disability. As the Veterans Service Officer, I can try to help you get money. But one day, the money is going to go away. One day, the money is going to run out, and one day, time is going to run out," Walker said.

"A statistic that is true for all of us is that one out of one people is going to die. That's a statistic that is true for everybody.

"And he (the VA chaplain) looked at me and he said, 'They can give you all the

help in the world there in the emergency room. They can give you people to talk to. They can give you pills, but there's only one thing that can actually save your life, and that's Jesus Christ.'

"From that day forward, I swore I would live for Jesus. Am I perfect at it? No, just ask my wife and the people around me. I've got a temper. I've got problems on top of problems. This hasn't made me a perfect man, but it has given me an eternity. It didn't give me something temporal, but something eternal," Walker said.

"And on that day, I said what David said in the next verse of that Psalm, 'I have asked one thing from the Lord...what I desire is to dwell in the house of the Lord all the days of my life...

"I asked Jesus Christ into my heart that day, and I surrendered my life because nothing on this earth that I saw could satisfy me," Walker added.

"You can seek things on this earth all day long. You can seek sanctification from money. You can seek sanctification from people. The problem is money runs out and people die, but Jesus is eternal. The one thing that is a sure bet is if you surrender your life to Jesus Christ, you have eternity in

Heaven," he told the crowd.

"So, if there's anything I can say to you veterans here today...I know there are a lot of problems we all run into. We all have a lot of things we do because of what we went through. If you come to my office, I will try my best to get you benefits, but if you come to my office and want the one thing that is eternal. I can sit down and talk with you about Jesus Christ, because that is eternal. That's something you can hold onto.

"I feel like all of the veterans out there are my family, and I would do each one a disservice not to tell you that the true life comes through the truth, which is Jesus, the way, which is Jesus, the life, which is Jesus. If you want that salvation today, you can do that, just bend the knee. Say Jesus Christ save me, forgive me. Let Him take over your life."

ended Walker his testimony of faith by inviting veterans to visit him, saying, "If you ever want to talk about anything like that with me, come on."

Following the program, veterans and their families attending the event lined up for lunch, with county commissioners and officials serving each one in attendance.
