## Permitting RVs and pole barns will result in lost tax revenues

out push to recruit new industries and incentivize local businesses to expand.

More businesses and higher property values result in increased tax revenue without having to raise millage rates.

We must also look at Panhandle communities – such as Mexico Beach -- who have recovered and prospered since Hurricane Michael to learn how to turn a disaster into a success story.

We must help coastal homeowners and businesses rebuild as quickly as possible, but now is also the time to enforce land development regulations (LDRs).

The county commission has a legal and moral imperative to ensure that the county's main asset (presently real estate) is put to the highest and best use to maximize property values.

Continuing to allow pole barns, campers, RVs and ancillary structures (outdoor kitchens, bathrooms and living quarters) on prime real estate in the coastal high hazard zones (Gulf front properties) will result in millions of lost future tax revenue when compared to what a beach home would generate.

RVs and camper trailers are not taxed the same as residential homes and generate significantly less in ad valorem taxes.

If the county chooses to continue to allow multiple RVs, pole barns and campers in coastal areas, perhaps it is time to consider an annual assessment or permit fee to help offset what the county loses in tax revenue if a home was built on that same parcel.

The county must comply with FEMA regulations, not only because it results in discounted flood insurance premiums, but because a failure to do so could mean FEMA aid will not be available the next time a disaster strikes.

Taylor County could also risk being ineligible for many state and federal grants, which require it to follow and enforce building codes and FEMA

If hard decisions aren't made now, the tax burden will shift to every taxpayer in Taylor

Where will the money come from to continue to operate our county without a significant reduction in services or a huge increase in taxes?

The county commission has scheduled a Tuesday, Jan. 28, workshop to begin this difficult

While the county currently has healthy reserves that can help soften the blow from some of the shortfall for a short period of time, draining that emergency savings account is not a sound longterm solution and would place Taylor County in a dangerous situation in the case of another

## Nelson 'taught the youth not to be afraid of digging into a matter to ferret out the facts'

High in 1960, he was the first of his family to attend college in Maine and San Diego, Calif., majoring in American history. He earned his Masters degree from the University of Maine, Orono.

Nelson proudly served in the U.S. Army National Guard of Maine and Vermont for a total of seven years and was honorably discharged in 1970

Nelson served one term in the New Hampshire House of Representatives (1973-74), and then worked as a research analyst for federal government relations and lobbying organizations in Washington DC.

Several of his friends give deeper insight into who he was.

Maultsby, J.P. fellow Madison County Republican Party member, recalled that Nelson was exceptionally well-versed American historical politics.

Nelson got involved in the Madison County Republican Party in the early 2000s and continued through the 2024 election. Nelson was always digging deeply into poll data and election results to draw insights on how Madison County was progressing and where and how our efforts should be made to further Republican gains.

He was a "doer" and worked behind the scenes. homemade signs would pop up all around the county. He rejoiced at Madison County turning "red" in 2024. He had worked hard for that.

Nelson was a scholar. For years, he traveled four days per week to Valdosta University library to research for his planned book, a resource manual he wanted to avail to graduate and undergraduate students in American history.

He was a writer. In May 2010 the GOP started a weekly article in the local newspaper called Conservative Corner." Soon, Nelson took over as the primary author, and later changed the name to "Passing Parade." Several hundred articles ensued over the years. He understood that the written word had great historical significance when preserved.

Virginia Fuller, former Congressional candidate, says that Nelson told her that before he moved from Maine to Florida, he did his research and knew exactly which region in Florida he would target to deploy his plan. His objective was to turn regions of Florida from blue to red. He picked Madison County.

She further recalls Nelson's dedication conservative cause,

often making or ordering campaign signs and banners to put out for conservative candidates, regardless of whether he knew them, without being asked, and all at his own expense.

In 2018, Nelson sought Ms. Fuller out after he heard her radio interview as a congressional candidate. When they met in person, Nelson knew instinctively that she was the vehicle he objective quickly. He was very generous and offered her free housing in the heart of Tallahassee for the remainder of that campaign season.

Nelson never missed an opportunity to express support and appreciation when Fuller ran for office, saying she showed great courage when she dared to ride on the Republican float in the parade, demonstrating to all, black and white, that it is okay to stand up for your conservative values.

He believed that if she hadn't run for that empty GOP slot, Madison County wouldn't have voted red and helped the Republicans to victory that campaign

Brenda Dickenson, founder and lobbyist for American Homeschoolers observed his generosity, recalling that Nelson donated the use of his building near the

Florida Capitol to nonprofit organizations such as Eagle Forum and Right to Life for about 10 years beginning in 2000.

Bob & Linda Bezick, former Madison County Republican Party leaders, recalled that Nelson was on a mission to spread conservative values by ensuring that Americans knew the history of our great nation and how needed to accomplish his conservative movements flourish.

> He seriously took his duty to further the conservative values for the next generation. Nelson lived

> frugally, and yet he would generously sponsor students to attend Future Leaders conferences, paying in full for their flights and class fees. He did that often throughout the years.

> He didn't just say "believe me," rather, he always had statistics. historical documentation or other evidence that proved his words.
